I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the Commonwealth of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and legal effect.

I, being of lawful age, in consideration of being permitted to use the above described space and/or participate in and/or observe the Nazareth Adult Soap Box Racing Association races and/or events in Nazareth PA, release and forever discharge Releasees of and from any and every claim, demand, action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death, and/or property damage which may occur as a result of my using the above described space and/or participation in and/or observation of the Nazareth Adult Soap Box Racing Association races and/or events in Nazareth, PA or any activity in connection therewith, whether by negligence or not.
